All persons in attendance at the public hearing will need to practice appropriate social distancing and are advised that pursuant to Governor Pritzker's Executive Order 20-10, Executive Order 2020-18 and CDC guidelines and CDC guidelines, no more than 10 people will be allowed in the public hearing at any one time. Persons in excess of 10 people may be asked to wait in a different location until their time to be heard occurs.
