APPROVAL OF MINUTES: Motion made by Diana Caffero, Seconded by Hilde Kilian, all agreed.

GUESTS AND PUBLIC COMMENTS: Will be addressed by Kim Vigue and Dan Malone during Chairman's report.

LIBRARY REPRESENTATIVE: Caution in back alley of library because under construction and back entrance is closed. Joe Blum will move more stuff to school but may have to take out front entrance of library. Our internet line may have been cut according to Diana Caffero.
