up through normal pick-ups. However, Groot will collect, at the curb, up to six electronic items for \$30.00. Contact Groot at 800-244-1977 to schedule a collection. **Please remember also that residents may drop off electronics for free behind the Public Works garage in the designated container marked Electronic Recycling. If you have a large TV, village employees would be happy to assist you in disposing of it when you come by to drop it off. Just call ahead to make sure someone is there.**

As for large appliances, refrigerators, freezers, ovens/stoves, washers and dryers, air conditioners, humidifiers, dehumidifiers, water heaters, water softeners, dishwashers, furnaces, etc., these require a special pick-up and separate disposal is required by the State of Illinois. Items will be picked up at no charge, but residents must call Groot at 800-244-1977 to schedule a pick-up in advance.

We would appreciate your cooperation in this regard. Our ordinances allow for fines to be imposed for violators of these rules, but we are hopeful that residents will take heed and abide by them.

O'Hare Update

Unfortunately, we are unable to do a lot with the daytime noise, but, at the last ONCC meeting, the members tried to pass a revised Nighttime Fly-Quiet program that would have rotated runways, allowing for at least some reprieve for weary residents on either a daily or weekly basis during the overnight hours. Disappointingly, some of our neighboring communities voted against the plan saying they did not want planes being diverted over their towns, so the plan did not pass. These are the same towns that benefit economically from being in close proximity to O'Hare airport, so I feel they should shoulder some of the burden of flights going over our heads. Needless to say, I was shocked in the lack of support for the plan.

However, another Nighttime Fly-Quiet program will be presented at the next ONCC meeting scheduled for May 6th and we are hopeful this one will pass. I will keep residents informed on this and how the program will be tested over the summer. There will be surveys that the residents affected by O'Hare noise will be able to fill out once the test period is over to give the ONCC, the CDA and FAA feedback on the program.

I will continue to seek further soundproofing and improved soundproofing for residents of Schiller Park. Watch for further updates about O'Hare in the Schillergram along with visiting the village's website. Please be sure to check the Village Calendar for upcoming events. May events include the Fire Department Ice Cream Social on Friday the 20th, our annual Armed Forces Day Wall of Honor ceremony on Saturday the 21st, and the Village Wide Garage Sale on the 27th and 28th. We hope to see you at some or all of these events.

New Police Chief Appointed!



Thomas Fragakis was appointed by Mayor Piltaver on April 7, 2016 as the Chief of the Schiller Park Police Department. The Schiller Park Board of Trustees unanimously confirmed the Mayor's choice for the Village's new Police Chief.

Chief Fragakis started with the Police Department in January of 1985. He was promoted to Sergeant in 1990. He was made a Watch Commander in 1993. In 2011, he was promoted to the rank of Lieutenant. At the time, he was put in charge of the Detective Division. After 5 years in the role of Commander of Investigations, he has now been placed in charge of the 33 full-time sworn Officers, 5 part-time Officers, 5 Auxiliary Officers, 8 civilian employees, and up to 40 part-time employees that comprise the Police Force.

Chief Fragakis believes, as Albert Schweitzer did, "Success is not the key to happiness. Happiness is the key to success. If you love what you are doing, you will be successful." Chief Fragakis, not only has received training in numerous leadership and management classes throughout his career, but has also attained two Master's Degrees; one in Criminal Justice and the other in Business Management.

The Chief shares the philosophy of the *Strengthening Police-Community Trust* panel that, "It is important for a police force to reach out to the community, to interact with a cooperative spirit, to listen and act with respect and fairness, and to understand the value of fostering trust day in and day out, so that trust doesn't break down when there is a crisis." In other words, Officers and the Community have to work together; and, Chief Fragakis looks forward to working with you!

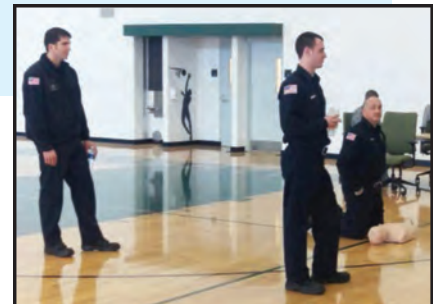
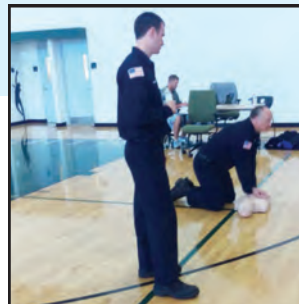
Fire Department Offers CPR Training to Students



Recently some of our Fire Department members participated in furthering safety education at Lincoln Middle School for the seventh grade class. This past February, as discussed in the last edition of the Schillergram, our members went to LMS to educate and discuss the importance of heart health and knowing what to do in case of a cardiac emergency. A guest speaker also attended who was a patient that had been resuscitated by the Fire Department two years ago following a cardiac arrest. He was 31 years old at the time of the incident. The students were taught the use of AED's and signs/symptoms of a cardiac event and that it can affect people of any age.

We continued to build upon that training by teaching the students "hands-only" CPR. After a brief presentation with the students, all were divided into groups led by a Firefighter/Paramedic and allowed to participate and learn how to properly perform hands-only CPR on a CPR mannequin. The students were eager and excited to learn! Over 120 students received this education and also had some great questions for our department members.

In the state of Illinois, it is mandatory for a person going through driver's education to become CPR certified, also known as "Lauren's Law". We as a department feel that people younger than 15 years old can be effectively taught to aid in such an emergency and have the potential to help save a life. The department wants to thank Lincoln Middle School and its administrators for allowing us to teach such a valuable tool to the students. It was a great experience and the students were great participants.



Fire Department Receives New Lockers

Over the past several months, the Fire Department has undertaken one of several projects around the fire house. This is our “home-away-from-home” and as such, are continuing to make improvements. The newest project has been a big change to our bunk room (the sleeping quarters and locker area). Walls have been patched, repaired, and painted. New tile trim has been added. Also, some new doorways were built. The biggest change are the brand new lockers. One of our department members, Lou Bertocini, had hand-built the previous lockers several years ago. They had definitely served their purpose and were beautifully crafted. However, in the interest of the new changes and improvements, the Fire Department recommended to the Village Board that it was time to purchase new larger lockers to allow for more interior storage so there would be no need to store things on top of the lockers. The old lockers were disassembled and parts were repurposed as they were mainly constructed of oak. The new lockers have been installed and are officially in service. It is one of many changes the department has seen over the years, and it will not be the last! All the department members had a hand in this project and the team work paid off. The Department thanks the Mayor, the Village Board, and the public for the resources that made these new lockers for their living space possible.

Schiller Park Electric Aggregation Program UPDATE

The Village is currently operating a Municipal Aggregation program. The purpose of the program is to identify and implement lower electric rates for Schiller Park residents' home electric bills. The program allows the municipality to seek proposals from electric suppliers, in an effort to lock in rates that are lower than those available through Commonwealth Edison. If you have not previously selected your own alternative supplier, not opted out of the Village program, you have been included automatically in the Village program.

The Village first operated its Aggregation program from 2012-2014. The program was extremely successful during the first two years, saving the average ratepayer nearly three hundred dollars, for a Village-wide cumulative savings approaching \$800,000. But the program was suspended in 2014, because the Village was not able to obtain pricing that was lower than ComEd's. All residents were returned to ComEd at the end of the initial program in 2014.

Last year, the Village again sought bids and selected Dynegy Energy (based in southern Illinois) as the new supplier. The rate was set at 6.851¢ per kWh for the first 12 months and is scheduled to drop to 6.39¢ per kWh for the last 12 months of the two-year term. Your rate will drop in September 2016.

The base default rate available through ComEd was set in 2015 at 7¢ with a monthly variance of +/- 0.5¢ per kWh due to the Purchased Electricity Adjustment (or “PEA”). In other words, the ComEd rate will vary from 6.5¢ to 7.5¢, through June 1. Unfortunately due to the monthly variances being credits since October of 2015, the current Aggregation program rate has been slightly higher than the monthly-adjusted ComEd rate, costing residents and small businesses that are in the program approximately a \$1.00 to a \$1.50 more per month than the ComEd rate since October of 2015.

The ComEd rate will reset June 1st at a yet-to-be announced rate to take effect June 2016 to May 2017. It may or may not be lower than the Village's rate of 6.851/6.39¢. With no early termination fee, residents are free to leave the aggregation program at any time to move to ComEd or to another supplier. After a six-month hold period, anyone who leaves the program may return with there being no penalty fee to leave, or to re-enroll. Residents may call Dynegy at 844-351-7691 to leave the Village's program to move back to ComEd if they so desire.

The concept of Customer Choice as introduced to the State of Illinois over 15 years ago has met with great success across the State, saving ratepayers billions of dollars: Residents were formally charged 9¢ per kWh for electric supply in the summer of 2010, and Illinois rates were near the highest levels in the nation in the 1990s and through the early 2000s. However, today Illinois electric rates are among the lowest in the nation, with all other Great Lakes States such as Michigan and Wisconsin paying higher rates than Illinois.

This program presents several benefits: ratepayers enjoy the flexibility to join or leave the program with no termination fee at any time; residents receive a fixed, known rate versus the ComEd rate which is re-set twice annually and can further change with the PEA charge that as stated above varies from month to month.

Residents are always advised to review and understand electric supplier offerings. The ComEd rate is available as a default provider if a resident is so inclined to move back to ComEd. Residents may also explore other providers via a website established for this purpose by the Illinois Commerce Commission: www.pluginillinois.org. Ratepayers are advised to review terms and conditions to understand any additional fixed monthly fees, termination fees, or variable rates with no upward cap. Again – there is never a penalty for leaving the Village's aggregation program. Mosquito Season Is Upon Us Please Use Caution

By this time of the year you will start seeing mosquitoes and now is the time for mosquito prevention. Mosquitoes in Illinois carry 5 different diseases including the West Nile Virus and the potential to carry the Zika Virus, although according to the CDC there has been no mosquito to person transmission of the Zika Virus so far in the United States. According to the CDC the best ways to protect yourself from being bitten by mosquitoes is to use an insect repellent, covering exposed skin with long sleeved shirts and pants, and to keep the mosquitoes outside. Speaking of outside, the best way to prevent mosquitoes from breeding is to remove standing water around your home. Around Town

Community Development News

Community Development is excited to welcome MyKitchens LLC to the Village of Schiller Park. MyKitchens is moving in at 9416 Irving Park Rd and will offer affordable shared commercial kitchens for rent and a business development center with no hidden costs. Suzana Stoltz, the owner of My Kitchens LLC, envisions an opportunity for food entrepreneurship. MyKitchens LLC is working with Schiller Park on starting on-site sale at their 3 Seasons Farmer's Market and Christmas Market International. Community Development

UPDATE

In addition to working on the Schiller Park comprehensive plan, Community Development staff members are involved with numerous projects. The coming year should see significant development, and Schiller Park is on the cusp of a transformation.

To that end, River Road should see a major improvement. Filling a recently vacated business will likely be a new high-tech laser tag facility, a microbrewery/restaurant as well as providing a new larger home for an existing business that was considering moving out of town. Retention of current businesses is just as important as bringing in new business – if not more important!

The West Gateway area at Irving Park and Mannheim Road is on the verge of being developed with two new hotels and a conference center. The vacant restaurant pad adjacent to that area has several proposals from nation-wide restaurant chains. The recently vacated Thrifty Car Rental lot on Mannheim Road has several offers, possibly to build an additional hotel.

In other parts of town, the old Hostess buildings will soon be torn down and two new office/industrial buildings will be constructed. Wally Park at Lawrence Avenue and Mannheim Road will be retrofitting their buildings for indoor parking. The owners are still working with IDOT for ingress and egress off Mannheim to encourage restaurants to come into their buildings. Developers have also submitted plans for the corner of Scott and Irving Park Road which will go before the zoning board. Plans are underway for the long vacant BP gas station on Irving and River Roads to be remodeled with a new gas station and drive through restaurant.

These new developments have the potential to bring in over a million dollars in construction/permit revenues, sales tax revenue, hotel tax revenue and property tax revenue to the Village. These projects will also create many new job opportunities for our residents.

All of this will help the Village continue to be a great place to live, raise a family and own a business.
